## 45<sup>th</sup> Annual State 4-H Horse Show — Huge Success

The 45th annual State 4-H Horse Show was held in Abilene, Texas on July 22-28, 2007 at the Taylor County Expo Center. Many thanks go out to Mr. Tony McMillian, his staff and host CEA's Kit Horne, and Gary Bomar for helping make this show continue to be a tremendous event for the 4-H'ers and their families. Additionally, the 46<sup>th</sup> State 4-H Horse Show will be held at the Taylor County Expo Center in Abilene.

4-H'ers from 155 counties across Texas were entered in the show this year. A total of 848 4-H'ers entered 1047 horses. That combination of 4-H'ers and horses resulted in over 2764 entries in the horse show.

The High Point Winners in each of the Five Divisions are listed below: Stock Horse Division—Alicia Daugherty, Brewster Co.; Roping Division: Tye Thompson, Stephens Co.; Hunter Division—Morgan Redwine, Taylor Co.; Timed Event Division—Nicole Thompson, San Augustine Co.; Western Judged Division—Serena Brock, Brazoria Co.

For the sixth year, Wrangler has awarded \$700 scholarships to the 4-H'er that accumulates the greatest number of points in each of the five divisions at the State Horse show. To be eligible, a 4-H'er must have graduated

and be enrolled in or enrolling in a trade school or a college or university. The winners were: Stock Horse—Alicia Daugherty, Brewster Co.; Roping—Will Braim & Trent Taylor, Comanche Co.; Hunter— Kelly Morris, Mitchell Co.; Timed—Sidney Cumberland, Kleberg Co.; and Western—Serena Brock, Brazoria Co.

**Joe Don King** (Wheeler CEA), **Doug Shores** (Harris CEA-4-H), and **Mac Gilliat** (Real CEA) received Appreciation Buckles for 40 years of involvement with the State Show.

Each of these men have been involved since shortly after the show began back in the 1960’s, and continue to serve in various capacities at the show each year.

**Gary Antilley**, who just retired this year from King County Extension, was given a pair of Appreciation Spurs for his long-time service on the Management Team. Gary will

types of subject matter fit in with the Incident Resource Team (IRT) objectives to address Animal Issues, Special Storms, Drought, Flood and other emergency situations that can affect horse owners across the state.

## Foreign Animal Zoonotic Disease – Horse Bio-security

As part of this Department of Homeland Security initiative, work is nearing completion on Best Management Practices related to horse keeping and transportation. The

printed materials will be finalized and provided as supplemental information for ongoing education in horse management and use, with opportunity for placement of some

materials in web-based educational delivery systems.

## Texas 4-H Master Horse Volunteer Training

The Texas 4-H Master Horse Volunteer training will be held December 4-6, 2007 at the San Angelo Research and Extension Center in San Angelo, TX. The program will begin on Tuesday, December 4<sup>th</sup> at 3:00 p.m and conclude on Thursday, December 6<sup>th</sup> around 3:30 p.m. The primary purpose of the program is to train horse project leaders to provide support to new 4-H horse project members (families in 1-3 years of participation in horse project area). The training will provide these project leaders with a valuable set of resources from which to build and support families in their county who are new to the 4-H horse program. The Master Volunteers may also provide support for other activities and county 4-H horse program as requested by agents. The requirement for a 4-H Master Volunteer is to participate in 20 hours of approved training and then provide 50 hours of “pay back” volunteer time in their local 4-H program under the supervision of the local County Extension Agent.

The training is targeted for adult project leaders that are approved by their local County Extension Agent. The training will focus on two central themes, training volunteers in youth development and horse project subject matter, in order to better support the program in your county. Participants must complete the entire course, in order to meet eligibility requirements to become a Texas 4-H Horse Master Volunteer candidate. Upon successful completion of candidacy, volunteers will be eligible for Master Volunteer status.

Registration will take place via the 4-H CONNECT website. Registration costs for this event include meals, refreshments, educational resources, and other program expenses. Early registration will be \$100 from October 15 through November 15<sup>th</sup> and late registration will be \$125 through November 30<sup>th</sup>. All volunteer registration must be approved and “certified” by the sponsoring county Extension agent using the 4-H CONNECT online registration system.

The annual Texas State Youth Reining Horse Clinic for 4-H members will be held December 15-16, 2007 at the Taylor County Expo Center in Abilene, Texas. Youth attending must be a bonafide 4-H member and bring a horse they want to improve in executing all basic maneuvers. The horse does not have to be a Reiner. If under 16, members must provide their own parental or volun-

teer supervision. Stalls will be available on Friday, December 14, 2007. The clinic will begin at 9:00 a.m. on Saturday, December 15. Topics will include lateral flexion and forward momentum, circles, spins, stops, rollbacks, and lead changes. All participants will receive "hands-on" practice and assistance throughout the clinic. This clinic is a project of the Texas State

## Futurity Rule Reminder

Attention: This is a reminder that will be in effect for the 2008 Texas 4-H Horse Show. 4-H'ers nominating a futurity project horse must be at least 12 years old. This means that on August 31<sup>st</sup>, 2007, the beginning of the current 4-H year, the 4-H'er must be 12 years old or older to nominate and exhibit a futurity project in 2008. The Texas 4-H Horse Show offers five futurities to 4-H horse exhibitors as follows: Yearling Halter Geldings, Yearling Halter Fillies, Yearling Longe Line, Two-year-old Western Pleasure and 3-Year-Old Stock Horse.

## Judging Teams Represent Texas 4-H at Southern Regionals & World Championships at AQHYA World Show

**Lubbock County** was the winning team this year at the State 4-H Roundup Horse Judging Contest. The team members were Audra Head, Katie Haukos, Logan Jackson and Tyler Jasper. The team was coached by Mr. Will Golden. By winning this contest, Lubbock County qualified to represent Texas 4-H at the Southern Regionals, the AQHYA World Show, and the All-American Quarter Horse Congress. The team traveled to Ft. Worth, TX to compete at the AQHYA World Show contest in the 4-H/FFA Division. They finished 4<sup>th</sup> overall in the contest and they were 3<sup>rd</sup> in the performance division. Audra Head was the Overall High Point Individual in the contest and finished 3<sup>rd</sup> in the performance division.

**Johnson County** was the 2<sup>nd</sup> place team at Roundup; and this placing qualified them to represent Texas 4-H at the Southern Regionals and the AQHYA World Show. This team traveled to Memphis, Tennessee to attend the Southern Regional contest and placed 6<sup>th</sup> overall. Madison Simmons finished 10<sup>th</sup> overall in the contest.

## State Method Demonstration & Public Speaking Winners

Chelsea Campbell, **Deaf Smith County**, was 1<sup>st</sup> at State Roundup and qualified for the Southern Regionals in Memphis, TN, the All American Quarter Horse Congress in Columbus, OH and the National Western 4-H Classic in Denver. Alexis Cowan, **Robertson County**, was 1<sup>st</sup> in Individual Method Demonstration for Horse at Roundup and qualified and participated in the Southern Regionals in Memphis,

TN. She also qualified for the National Western 4-H Classic in Denver, CO, and the All American Quarter Horse Congress in Columbus, OH contests. Max and Marta Goerte, **Fannin County**, were the Champion Demonstration Team at Roundup and qualified for the Southern Regionals in Memphis, TN, the National Western 4-H Classic in Denver, CO, and the All American Quarter Horse Congress

in Columbus, OH contests. The team was unable to attend the Southern Regional Contest. The team of Georgia Loop and Kayla Weaver, **Cameron County** finished 2<sup>nd</sup> overall and qualified for the Southern Regionals and the All American Quarter Horse Congress in Columbus, OH contests.

## Horse Theft Awareness Education Summary

During the first 8 months of the year, **21 County Extension Offices** were involved in 31 of the educational programs/exhibits on this initiative. Those programs reached **4,814** horse owners/enthusiasts. Several of those programs were tied to **Basic Horse Management 101 Workshops** in various locations. Another **35 County Extension Offices** were involved in reaching **1,025** youth, parents and volunteers

in the 35<sup>th</sup> Annual Summer Horsemanship Schools, which include a session on best management practices to minimize theft. The **14<sup>th</sup> and 15<sup>th</sup> Law Enforcement Trainings** were held in College Station and in Schleicher County, with special thanks to **CEA Corey Stevens** for hosting the west Texas training. Two special segments were aired on RFD TV's Ag Lifestyles, and reached **several million** viewers.

Over the past 10 years, this initiative has involved over 600 programs, demos and exhibits across the state. It has also been the focus of 8 national/international television programs. Although funding for the initiative has stopped, CEA's can still utilize printed materials, banner display and DVD to educate horse owners on theft prevention best management practices.

## Status of Horse Slaughter in Texas

This has been a controversial issue, particularly with activity for and against, in the past three years. As of now, horses are no longer being received for slaughter with meat exported overseas for human consumption. It appears also that federal legislation is being considered relative to the laws governing the export of live horses. Canada and Mexico both have horse slaughter facilities where the product is shipped out for human consumption on other countries. Several years ago, there were horse slaughter facilities in Texas, Oregon, Nebraska

and Illinois. It appears that the Illinois plant was granted temporary permission to operate while certain laws/actions were being debated or disputed. However, it is important to recognize that the export of live horses go far beyond the issue of horse slaughter, as U.S. horses routinely leave the states being exported for showing and racing all over the globe. It remains to be seen how recent changes in horse slaughter will impact horse prices at various market levels, and the overall well-being of horses across Texas. Preliminary planning is un-

derway between Texas Cooperative Extension and the Sheriffs' Association of Texas to develop a series of education workshops for law enforcement officers that address animal care/neglect/abuse for cattle, for sheep/goats and for horses. As these workshops become better developed, there will be opportunities for CEAs in strategic locations across Texas to become involved.

## Update on National Animal Identification System—Horses

There has been a lot of interest, concern and mixed emotions about the NAIS as pertains to various components such as premises identification, horse identification and recording of horse transport. The Equine Species Working Group (ESWG) is a committee that functions to interact both with the horse industry and with the USDA to critically evaluate items being considered and to provide input that is supportive of the best interests of the horse industry. At this time, the NAIS continues to be completely voluntary, and here in Texas, the registering of a premises (location where horses are kept) is completely optional/voluntary. There is strong indication, that if permanent identification of horses ever were to become mandatory, that the mi-

crochip implantation would be the recommended method of horse identification. However, it continues to not be regulated at this point, and permanent marking of horses is at the discretion of the horse owner. The ESWG has spent considerable time evaluating the use and status of various implantation chips for horses. There are 125 Kz chips that are 10 digit chips. There is indication that these older 10-digit chips will continue to be recognized because several thousand horses already carry these chips in the nuchal ligament (top part of the neck). Newer 134Kz chips are 15 digit chips and permit use of a country code. They are often referred to as an AIN 840 chip. At this time, there are not 840 microchips in production.

Neil Hammerschmidt, the USDA/APHIS/VS/NAIS Coordinator again reiterated at the June ESWG meeting that premises registration is the current and primary focus of the NAIS. Apparently, the major concern for a Premises Identification Number (PIN) is for location identification related to disease programs. The NIAA Equine ID Subcommittee also met earlier this year in California to discuss ESWG recommendations, certain diseases, and the status of equine ID in other countries. ## First Microchip Approved for Use in NAIS

During the National Institute for Animal Agriculture's ID Info Expo held in Kansas City, MO, USDA announced the approval of Digital Angel Corporation's (formerly De-stron Fearing) Life-Chip equine radio frequency identification (RFID) injectable transponder for use in the NAIS.

The LifeChip is the first equine

RFID microchip to be approved for use in the NAIS. The chip is ISO compliant, containing a passive transponder programmed with a unique 15-digit number that can be read by any ISO-compliant reader.

The microchip also has a Bio-Thermo temperature-sensing technology feature. Additionally, each chip is capped with a patented, bio-

compatible material called BioBond which prevents migration, an item that was necessary to gain USDA approval.

## Law Enforcement Training Held at TAMU

Consistent with the legislative challenge that TCE conduct ongoing education in horse theft awareness to include law enforcement officers, the 13<sup>th</sup> day-long training was held at TAMU in February. Co-sponsored by TCE, the TSCRA and the Sheriffs' Association of Texas (SAT), there were 40 officers from 16 counties who accessed informa-

tion on premises ID, permanent identification of horses and recognition of various colors and markings. These workshops have been expanded to assist officers with body condition score determination relative to animal cruelty and abuse cases across the state. So far, 586 officers from over 140 Texas counties have attended these specialty

workshops. With a 98% response to outcome measures, 75% report increased competence in communication with horse owners and in recognizing horses based on identifying characteristics. TCLEOSE credit is made available to officers via the SAT.

## Horse Feed Industry Workshops

Pete Gibbs continues educational work with major feed manufacturers. This year is the 16<sup>th</sup> year for targeted workshops that educate Territory Managers or Select Dealers for feed companies, as well as veterinarians who work with horses and horse owners. So far this year, one CEU training has been completed for equine practitioners, providing 2 CEU credits to 32 veterinarians across those counties that make up the **Hill Country Veterinary Association**. The target audience is relevant because veterinarians are listed as a primary contact by horse owners for nutrition-related information. TCE continues to be involved in supplementing their expertise in livestock nutrition. Veterinarians place the value of such workshops at \$50 to \$75 per hour. Then, the **11<sup>th</sup> annual Cargill Animal Nutrition Horse Feed In-**

**dustry Workshop** was conducted for 25 Territory Managers from 12 states and Mexico. As a result of the training, the most significant knowledge gains were in 1) assessment of animal condition, 2) managing young, growing horses and 3) bio-security. Increased knowledge of safety around horses and horse operations approached Excellent as a result of the workshop. Across 13 subject matter areas, average incoming level of knowledge was 3.16/5 or 63%, compared to ending knowledge base of 4.11/5 or 82%. This collaborative effort has translated into 4-H horse program support of \$25,000 this year alone. Collaboration with major horse feed manufacturers includes a large number of educational programs targeting horse owners. In the past couple months, the **Friends are Forever Seminars**

in San Antonio and Houston offered feed-related information for over 650 horse enthusiasts. This fall, Cargill will co-host a horse owner program with **Titus County Extension in Mt. Pleasant**.

Lone Star Race Park in Arlington will be the location in November for a program being planned by **ADM Alliance Nutrition** for horse owners in the Dallas/Fort Worth metroplex. ADM Alliance typically calls on Texas Cooperative Extension annually to host their Veterinary CEU training here on the campus, and this year, they are obtaining similar educational support for this program at the race track. Texas Extension also has had other opportunities this year to work with major feed manufacturers on customer appreciation seminars in the San Antonio area.

## Texas A&M System Horse Research

The horse section, located here in the Department of Animal Science, had 7 papers presented at the 20<sup>th</sup> Equine Science Society meetings in Maryland. Horse Program Specialist **Teri Antilley** had a poster on her work with nitrogen retention to determine amino acid status in horses. **Graduate students** Rusty Kriewald, Trinetta Ross, Denise Manhart and Travis Lybbert had research project results at these

meetings that dealt with use of Racotomine in horses, response of horses to diets with Omega 3 Polyunsaturated Fatty Acids, management of older horses and dietary factors affecting Equine Gastric Ulcer Syndrome in horses. Denise Manhart received 1st place in the graduate nutrition competition. Rusty Kriewald received 3rd place in the graduate management competition. **Clay Cavinder** gave lead

to a presentation on the new **Horse Judging Team Coaches Workshops** for volunteer leaders here in Texas, a new initiative which is providing potential strength to Texas Extension's educational efforts for youth horse judging programs, and includes web-based judging classes for coaches and youth judges.

## 35th Annual Summer Horsemanship School Program

This year, 12 college students (10 female, 2 male) were hired as Horse Program Assistants and partnered up to teach horsemanship schools across Texas. Ten of the 12 instructors were new to the program. Thirty-six schools were conducted in 35 different counties, reaching 13.8% of the 254 counties in Texas. Twenty-six counties hosted 2-day schools, while 10 counties hosted 3-

day schools. There were 82 total teaching days that resulted in 656 teaching hours. The program reached 1026 different 4-Hers, parents and volunteers. Average attendance was 28 persons per school, with 18 riders and 10 adults watching. Instructors traveled 7,783.6 miles, not including inner city mileage, for an average of 7.59 miles per person reached.

Over the 35 years, 1,208 schools have been conducted, reaching 43,341 youth, parents and volunteers. The program represents 3,516 teaching days, for a total of 28,128 teaching hours. There have been 201 different instructors (155 female, 47 male) who have served as Horse Program Assistants.

**73%** “Definitely” could do one or more advanced maneuvers that they were previously unable to do

**68%** “Definitely” could make more informed decisions on when/how to ask their horse to perform a task

**66%** “Definitely” could ride with more confidence

**69%** “Definitely” could solve a problem they were having before the clinic

**61%** “Definitely” could recognize the relationship between basic and advanced maneuvers

**73%** “Definitely” felt more competent in working their horse

**73%** “Definitely” enjoyed their horse more

## New Texas A&M Stock Horse Team Competes at Inaugural Intercollegiate Stock Horse Competition

The Texas A&M University Stock Horse Team competed at the Inaugural Intercollegiate Stock Horse Competition held at Texas Tech University in Lubbock on April 29th. This was the first ever contest of this type held for college students. Over 60 individuals from Clemson University, Stephen F. Austin University, Sterling Colo-

rado Junior College, Tarleton State University, Texas A&M University, and Texas Tech University competed in the competition. Of the seven competing students from Texas A&M, four placed in the top ten overall in various divisions with several top five placings in individual classes. Students competed on Texas A&M University-owned

horses in four different judged events including pleasure, trail, reining and cowhorse. Competitions are planned for this fall. The team is supported by private donations from Mayer Cattle Company and the Brazos County Horse Extension Committee.
